

Informations to tmg-quotations

The accompanying offer has been made to meet your specifications and to reflect the technology currently available to tmg. Please check that the technical details and any sketches or drawings are indeed in agreement with your requirements, both as to accuracy and as to completeness. Any statements on tolerance or accuracy relate exclusively to the temperature sensor. Concerning specifications of lengths DIN 7168 – general tolerance "medium" - is valid. Cable lengths are liable to a tolerance of \pm 3% depending on the manufacturing technology! The thermal error which can arise thorough radiation and conduction of heat where the sensor is installed or attached must be taken separately into account by the user, by reference to the VDI (German engineers' association) guidelines 3711, 1–5 (for example).

The conditions of supply drafted by the AMA (German sensor manufacturers) as updated to 04/2002 are the base of the quotation. They can be downloaded from the Internet, for example from www.temperatur.com, are always printed on the reverse of tmg invoices, and can also be read in our catalogues.

We are always delighted to develop new solutions or adaptations for your temperature problems; in some cases this will mean asking you to share some of the costs of development and testing.

If a new data sheet for the specific type of sensor has to be produced, or documentation for a special one-off tailor-made device, 18 euros will be charged for the paperwork.

In general, the price quoted will stand for 60 days, but offers which include thermocouples making use of noble metals, for which parts the price will normally be calculated anew at the time of supply according to the official German Stock Exchange price recorded on that day. Unless otherwise stated, delivery date will normally be 3 weeks from receipt of order (with full clarification of all technical details). The general conditions of payment are 30 days net, 2% discount for payment within 10 days. The conditions of payment for new customers first purchase order are cash in advance, net, no discount. In the case of transactions involving noble metals, payment is to be made within 10 days with no deductions. Delivery is normally by post or parcel service and will be charged for. To be charged at extra cost: handling charge $10,-\varepsilon$ for all deliveries less than $50,-\varepsilon$; expenditures of bank transfer $15,50\varepsilon$ for all deliveries out of Germany (exception: remittance with SWIFT/BIC and IBAN inside EU).

If the products quoted for are not what you are looking for, please contact the person who prepared the quotation. tmg has a wide range of standard and special sensors at its disposal and there are doubtless a number of different ways in which your problem could be solved.

We would ask you to note that the technical parameters we have given are based on the figures we have worked out over many years of experience but that they will need to be checked on application to the individual situation. There are various special testing facilities which can be applied in the DKD (German Calibration Service) laboratory of our company, for example.

The supplier and those assisting in the supply bear liability for material damage up to the amount of $1,000,000 \in$ (euros) per damage incident, not more than twice in a year.

Claims for damages on the part of the customer, for whatever legal reason, especially in respect of breach of obligations in the context of indebtedness and of improper dealings, are excluded. After the end of limitation period for rights of remedy for defects in the goods, the customer may make no further demands. This rule will be applicable as appropriate in potential exemption situations where claims are by third parties.

We shall be delighted if you find this quotation acceptable. When ordering, please give both the quotation reference number and the serial number of the item being ordered, so that the version advised is supplied without risk of confusion.

We would like to draw your attention to the fact that we will not accept unannounced returns if the transport/packing is charged to our account.
